Frank Carroll Jr. – President Snowmobile Club- Club would like to still use the building. Being used as storage only. The Club did do some ceiling work. The Club will discuss with members what their future plans are. The Board agreed that they could put a lock on the door for safekeeping. Gene Gerry and Frank Carroll Jr. have keys to the building. The other key was turned into the office. Mr. Carroll stated that the membership is up, 70 plus miles of trails between Limerick and Newfield. Bringing back the Poker Run and running two dances, one in January in Limerick and one in April in Newfield. Maps are available for purchase. Jeff offered to have them available at his store.

General Assistance Appendix “B” hearing- Questioned about the maximums for GA. Bruce explained they have gone down making more difficult to receive GA. Back in regular session @ 8:01 p.m.


