- Open meeting with the Pledge of Allegiance

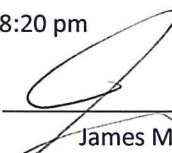
NEW BUSINESS

- Marijuana ordinance Repeal referendum vote brought about by citizen's petition. Board would like to hold the Public Hearing on Tuesday February 27th at 6:00pm at the Town Hall. Selectmen's meeting to follow.
- Complaint Form- received complaint form from Shawn Reekie regarding the lack of a stop sign and heavy truck usage on the South Effingham Road. A stop sign for the end of the road has been ordered. Shawn indicated that the loggers are working at 6am. Nichole contacted Jon Therrien to inform him of the noise ordinance (between 10 pm and 7 am noise levels are lower) He indicated he would abide by the 7am rule but this would mean he would be working later and clarified he could have the loggers working until 10pm. Shawn also mentioned some traffic issues with the loggers causing accidents and blocking traffic. When Jon was asked about this he indicated that at bus stop time the parents are actually blocking off the road. It was indicated to both parties that traffic violations are under the jurisdiction of the Sherriff's Office and State Police. Both agreed to be "more courteous".
- John Moulton RE: Rescue 2nd staffing article. John indicated that he did not have the history of calls to present to the Board and is hopeful to have them complete for next week (Finance meeting). John indicated that the reason behind asking for a 2nd person during the day is the per diem person is always waiting for a driver to response and we only have a few drivers. Jim indicated that is looks like they have increased on every one of their articles. John explained that they are hoping to get a new cardiac monitor as theirs is outdated. They will also be looking for assistance with this maybe through a grant. Jeff explained that he is having a hard time deciding whether to support or not support the 2nd staffing article as we has no numbers/info to compare. Jim mentioned that for safety reasons we should have a second person on staff; people cannot respond alone. Jeff explained there were times that the current per diem slot has not be filled/manned. John explained they have no "pool" of employees and usually it is the result of someone's kids being sick (not planned) Jeff explained that this is kind of late notice on the warrant article. The purpose of us having the quarterly meetings is to stay in the loop on what is going on and he feels this was brought to the Board late. Jim expressed wishing there was more interaction and solicitations from the public for volunteers. To be a driver you must have 16hrs of AVOC or EVOC training.
- Bob Burnham brought up an issue at the Fire Station. Edgar stopped by to look at new fire truck and inquired as to why we needed new air pacs. Dick McGlincey walked in an Edgar starting using profanities and Bob stepped in between them. Board discussed how this should be handled. Jeff indicated he would contact Edgar directly and discuss.
- Discussion on rugs for the office. Decided 7 rugs would be needed in winter and can drop it down in the summer.
- Nichole to contact Ashley Gerry about getting a 2nd price on the PSB stairs job.
